Dear Friends and Colleagues:

Change is coming! Join us at this year's Fall Forum for a fast-paced program discussing the most pivotal topics in antitrust as we tour an emerging enforcement area from investigation through appeal. Hear from the most senior enforcement officials from the Antitrust Division, the Federal Trade Commission, and state attorneys general about what's hot and what's likely to come following the election.

This year's program will delve into the increasingly congested intersection of antitrust, innovation, and regulation in the context of disruptive technologies. Investigators and litigators of conduct and merger cases will discuss how to navigate the tension between state and federal policy goals. Competition and consumer protection experts will provide a preview of the major challenges facing the new Administration.

We are excited to start the day with an overview by Acting Assistant Attorney General Renata Hesse on the relationship between state and federal antitrust enforcement. From there, we will tour the clash between antitrust policy and the growing body of state and federal regulations that may shelter from competition markets, conduct and mergers, with a focus on disruptive technologies and innovative service providers. We will have the "inside players," including senior government enforcers, prominent industry specialists, and outstanding practitioners leading the charge in this area. All of this will be shared from a practical perspective by current and former federal and state senior government officials and litigators, making this an ideal forum to learn how to successfully navigate a government investigation and litigation.

The afternoon will begin with a candid one-on-one conversation with Chairwoman Ramirez about the past, the present, and the future of antitrust enforcement. Next, some of the best thinkers in appellate advocacy will dissect the future procedural, tactical, and substantive options for litigating cases involving restraints on competition and mergers of competitors in the wake of the Supreme Court's landmark rulings in *North Carolina Dental Examiners* and *Phoebe Putney Health System*. This will be followed by a panel featuring the Honorable Maureen K. Ohlhausen and other distinguished speakers discussing whether it is possible to reconcile the conflict between the federal enforcers and sectoral regulators and the implications for competition in industries ranging from transportation to professional services to retailing, as well as others facing disruptive technologies.

Finally, we will end the day with a preview of the future of antitrust and consumer protection. The Co-Chairs of our Presidential Transition Task Force will identify issues the new Administration may tackle, and preview their coming report. This is something you won't want to miss.

There will be numerous opportunities to network and discuss what's new in antitrust with our distinguished speakers, colleagues, and friends. In addition, our luncheon will provide an opportunity for attendees to meet the faculty and network with other attendees. At day's end, attendees are invited to a networking reception with all of our distinguished faculty.

We can't wait to kick off this extraordinary program, which promises to be one of the most informative and useful antitrust events of the year!
